(IMCR) screened a total of 1,743 civilian initiated complaints at the Court Dispute Referral Center located at Bronx Criminal Court and at its Dispute Resolution Center in Bronx County. During the year, IMCR was able to achieve the following, among others: a. Screened: 1743 b. Cases Opened: 1743 c. Cases Scheduled: 2000 d. Cases Resolved: 1741. IMCR presented a simple and accessible mechanism for the resolution of interpersonal civil and criminal complaints and offered Bronx residents an Alternative Dispute Resolution Center - which provides parties a non-threatening environment for the resolution of interpersonal disputes. Both Mediation and Arbitration services are provided with the voluntary participation of trained community mediators and arbitrators. There is an 87% resolution rate when both parties to a dispute agree to mediate their matters.
